  - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
  - d. "including" is understood to mean "including without limitation";
  - e. reference to any statutory provision includes any modification or amendment of it;
  - f. the headings and sub-headings do not form part of this privacy policy.

# Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Rontaler PR & Events Ltd and Users with respect to this Website and Rontaler PR & Events Ltd's services. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Rontaler PR & Events Ltd is the "data controller". This means that Rontaler PR & Events Ltd determines the purposes for which, and the manner in which, your Data is processed.

## **Data collected**

#### How we collect Data

- 6. We collect Data in the following ways:
  - a. data is given to us by you; and
  - b. data is collected automatically.

# Data that is given to us by you

- 7. Rontaler PR & Events Ltd will collect your Data in a number of ways, for example:
  - a. when you contact us through the Website, by telephone, post, e-mail or through any other means;
  - b. when you elect to receive marketing communications from us;
  - c. when you use our services;

in each case, in accordance with this privacy policy.

# Data that is collected automatically

- 8. To the extent that you access the Website, we will collect your Data automatically, for example:
  - a. we automatically collect some information about your visit to the Website. This information helps us to make improvements to Website content and navigation, and includes your IP address, the date, times and frequency with which you access the Website and the way you use and interact with its content.
  - b. we will collect your Data automatically via cookies, in line with the cookie settings on your browser. For more information about cookies, and how we use them on the Website, see the section below, headed "Cookies".

#### Our use of Data

- 9. Any or all of the above Data may be required by us from time to time in order to provide you with the best possible service and experience. Specifically, Data may be used by us for the following reasons:
  - a. internal record keeping;
  - b. improvement of our products / services;
  - c. transmission by email of marketing materials that may be of interest to you;
  - d. for the purposes of contacting / replying to clients and prospective clients e.g. replying to email and web-from enquiries, correspondence with existing clients etc;

in each case, in accordance with this privacy policy.

10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate

interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).

- 11. For the delivery of direct marketing to you via e-mail, we'll need your consent, whether via an opt-in or soft-opt-in:
  - a. soft opt-in consent is a specific type of consent which applies when you have previously engaged with us (for example, you contact us to ask us for more details about a particular product/service, and we are marketing similar products/services). Under "soft opt-in" consent, we will take your consent as given unless you opt-out.
  - b. for other types of e-marketing, we are required to obtain your explicit consent; that is, you need to take positive and affirmative action when consenting by, for example, checking a tick box that we'll provide.

## Who we share Data with

  - b. third party service providers who provide services to us which require the processing of personal data to supply booked artists with necessary event contact information for visit purposes and vice versa; to supply publishers with information if booking is part of a promotional tour;
- c. relevant authorities to facilitate the detection of crime or the collection of taxes or duties; in each case, in accordance with this privacy policy.

## **Keeping Data secure**

- 13. We will use technical and organisational measures to safeguard your Data, for example:
  - a. we store your Data on secure servers.
- 14. Technical and organisational measures include measures to deal with any suspected data breach. If you suspect any misuse or loss or unauthorised access to your Data, please let us know immediately by contacting us via this e-mail address: victoria@rontalerevents.co.uk.

## **Data retention**

- 16. Unless a longer retention period is required or permitted by law, we will only hold your Data on our systems for the period necessary to fulfil the purposes outlined in this privacy policy or until you request that the Data be deleted.
- 17. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

# Your rights

- 18. You have the following rights in relation to your Data:
  - a. **Right to access** the right to request (i) copies of the information we hold about you at any time, or (ii) that we modify, update or delete such information. If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive." Where we are legally permitted to do so, we may refuse your request. If we refuse your request, we will tell you the reasons why.
  - b. Right to correct the right to have your Data rectified if it is inaccurate or incomplete.
  - c. Right to erase the right to request that we delete or remove your Data from our systems.
  - d. **Right to restrict our use of your Data** the right to "block" us from using your Data or limit the way in which we can use it.
  - e. Right to data portability the right to request that we move, copy or transfer your Data.
  - f. **Right to object** the right to object to our use of your Data including where we use it for our legitimate interests.

# Changes of business ownership and control

- 23. Rontaler PR & Events Ltd may, from time to time, expand or reduce our business and this may involve the sale and/or the transfer of control of all or part of Rontaler PR & Events Ltd. Data provided by Users will, where it is relevant to any part of our business so transferred, be transferred along with that part and the new owner or newly controlling party will, under the terms of this privacy policy, be permitted to use the Data for the purposes for which it was originally supplied to us.
- 24. We may also disclose Data to a prospective purchaser of our business or any part of it.
- 25. In the above instances, we will take steps with the aim of ensuring your privacy is protected.

#### **Cookies**

- 26. This Website may place and access certain Cookies on your computer. Rontaler PR & Events Ltd uses Cookies to improve your experience of using the Website and to improve our range of services. Rontaler PR & Events Ltd has carefully chosen these Cookies and has taken steps to ensure that your privacy is protected and respected at all times.
- 27. All Cookies used by this Website are used in accordance with current UK and EU Cookie Law.
- 28. Before the Website places Cookies on your computer, you will be presented with a message bar requesting your consent to set those Cookies. By giving your consent to the placing of Cookies, you are enabling Rontaler PR & Events Ltd to provide a better experience and service to you. You may, if you wish, deny consent to the placing of Cookies; however certain features of the Website may not function fully or as intended.
- 29. This Website may place the following Cookies:

Type of Cookie	Purpose
Strictly necessary cookies	These are cookies that are required for the operation of our website. For example, our dynamic pages (like our artist list), where the web-site visitor clicks on a link which request information from a database.  These cookies only identify a unique number assigned to the computer the visitor is using to allow the server to send the right information to the right computer and are only used for the duration of your visit to the site. No records of these cookies are kept after you have left the site.
Functionality cookies	These are used to recognise you when you return to our website. This enables us to personalise our content for you, and remember your preferences (for example, your choice of language or region).

- 37. This Agreement will be governed by and interpreted according to the law of England and Wales. All disputes arising under the Agreement will be subject to the exclusive jurisdiction of the English and Welsh courts.
